Judy does not have any diagnosed mental illnesses, but her daughter believes she has early onset dementia. Judy does not have a cell phone, nor access to a vehicle. The neighborhood was canvassed throughout the night but Judy was unable to be located. A local BOLO was issued and Judy was entered as a missing adult in state and national databases.
