Stolen Vehicle (Recovered)	19-5405	Palm Coast Pkwy NE	Communications received a BOLO from St. John's County reference a stolen vehicle that they were made aware was traveling South on A1A from their county. Deputies located the vehicle and conducted a traffic stop. The driver, and sole S1 was the suspect from the stolen vehicle case out of Duval County, FL (JSO Case # 19-20234). S1 was arrested reference Grand Theft Auto, possession of marijuana under 20g., and possession of drug paraphernalia.
CPR	19-5481	Office Park Dr (FIRST COAST HEART AND VASCULAR)	Female was at this cardiology office, and the Dr. believed she went into cardiac arrest. Prior to the arrival of deputies and FCFR, the doctor used their AED on the female. The female was alert and conscious upon the arrival of FCSO and FD.
CPR	19-5487	Putter Dr.	61 year old male was talking outside with his neighbor, when he had an apparent heart attack and fell over. The neighbor called 911 to report the incident, and CPR instructions were given by dispatch. Upon LEO arrival, FCFR Rescue 21 had assumed the scene. Once in the ambulance, vitals were restored by rescue personnel, and he was transported to FHF.
Larceny-Shoplifter-Narcotics	19-5494	Belle Terre Pkwy (Publix)	Management of Publix called to advise they had a female in custody reference shoplifting. It was later determined the suspect S1 had a warrant for her arrest from Marion County, FL reference VOP. S1 was placed under arrest for the warrant, and a search of her purse revealed a Morphine tablet, crack cocaine, a glass crack pipe, and steel wool. Publix wished to have S1 trespassed, and did not wish to pursue charges for retail theft. S1 was additionally charged with possession of cocaine, possession of drug paraphernalia, and possession of a Schedule 2 substance, without a prescription, and transported to the Inmate Facility.
Disturbance Domestic	19-5472	Woodbridge Drive	V1 stated her husband, S1 grabbed her arms during an argument last night. V1 had a bruise on her right arm where she claimed S1 grabbed her. Contact was made with S1 by phone who stated he would be home sometime after 6pm. 707 for DV battery was completed and held for the shift. Contact was made with S1 at Jail Admin and he was subsequently arrested.
