Burglary (Vehicle)	19-99734	Wayside Place	The victim's vehicle was burglarized sometime overnight. The rear passenger window of the vehicle was shattered and two female Michael Kors purses, a wallet and other miscellaneous items were missing that were left in plain view of the vehicle. All of the above property, to include the cash from the wallet was recovered on the property of 8 Wayside Place. Residents at 8 Wayside Place are not believed to be involved. All recovered property was turned over to the victim. Report by Deputy Gossett
Burglary (Vehicle)	19-99758	Pebble Stone Lane	The victim's vehicle was burglarized overnight between midnight and 3:00 AM. A rear window was shattered out and \$125 that was in plain view was stolen. Report by Deputy Gossett.
Disturbance (Domestic)	19-99761	Boulder Rock Dr	The victim reported that he was involved in a verbal argument with his juvenile sister that turned physical. During the argument the juvenile grabbed a metal mop handle and struck him several times in the chest/ribcage area and also in the head. The juvenile was determined to be the primary aggressor and upon Deputies placing the juvenile under arrest, she resisted and put herself on the floor. As Deputies escorted her to a patrol vehicle, she kicked another family member that was in close range. The juvenile was charged with aggravated battery DV, battery DV and resisting arrest without violence. The juvenile was transported to the Flagler County Inmate Facility for booking and was subsequently transported to the Department of Juvenile Justice (DJJ) after receiving their approval. Disturbance (Domestic)	19-99807	Bayside Drive	Verbal disturbance between 17yoa son and the rest of the family. No violence or threats of violence reported. Juvenile was permitted, by his parents to leave the residence for the evening. Report by Deputy Capela.
Death	19-99708	Cedarwood Ct	82 year old female found deceased by other family members that live in the residence. Nothing suspicious observed. Report by Deputy Dalrymple
Crash with Injuries	19-99783	Belle Terre Pkwy@Cypress Point Pkwy	Two vehicle crash with non-life threatening injuries. Both lanes of Belle Terre Pkwy Southbound were shut down for a short while due to the vehicles involved being disabled in the roadway. Report by Deputy Chambers

Larceny (Shoplifter)	19-99798	Belle Terre Pkwy	S1 was witnessed by loss prevention stealing merchandise. Once law enforcement made contact with him, he was found to be in possession of a concealed firearm. S1 stated he had a Florida Concealed Carry Permit, however it expired in 2017, making it invalid and not renewable due to being over 180 days expired.
