Narcotics	19-92433	Camino Del Mark Parkway	Deputy Gaddie performed a traffic stop on a vehicle for speeding and for running a stop sign. During a consent search of the vehicle, heroin and needles were located underneath the driver's seat of the vehicle and a Clonazepam was located in the passenger's backpack. S1 was arrested for possession of heroin and possession of drug paraphernalia. S2 was arrested for possession of a controlled substance without a prescription. Upon arriving at the Green Roof Inn, S2 advised that he had a baggie of heroin concealed in his buttocks and he was additionally charged with possession of heroin. Report by Deputy Gaddie.
Fraud, Grand Theft	19-92368	State Road 100 (Game Spot)	RP stated that two unknown black males entered the store last night and purchased three Nintendo game systems using counterfeit money. RP's employee, O1 stated that the money they provided felt different and did not check the money with a counterfeit pen until after the unknown males had already left the store with the merchandise. Narcotics	19-92439	Landing Blvd	Sergeant Biss observed a Volkswagen Jetta at E State Road 100 and Landing Boulevard and ran the tag in FCIC/NCIC to check for validation. The tag came back assigned to a red 2 door Ford and not a Volkswagen. Sergeant Biss then conducted an investigatory stop at the Landing Boulevard traffic circle and ultimately arrested the driver, S1 for driving an unregistered vehicle and attached tag not assigned. An inventory search of the vehicle was conducted and the following felony drugs were found: Fentanyl Citrate, Midazolam, Ondansetron (Zofran), Kenalog-40, Triamcinolone Acetonide, Cefazolin. The drugs were identified using the Raman Spectrometer. S1 was additionally charged with four counts of possession of Legend and Controlled Substances and felony VOP.
