<b>Robbery-Person</b>	19-117366	Prospect Lane	Units responded to Advent Health for a victim that came in with a laceration to the head. The victim stated he was "pistol whipped" in front of the above address.
<b>Disturbance-Domestic</b>	19-117138	Native Oak Ct	S1 had been drinking alcoholic beverages all night and causing issues for the whole family. The family called the sheriff's office around 12am, but there was nothing criminal at that time. Around 0700 we were called again because S1 had head butted his brother. S1 was arrested for Battery (domestic) and was brought to Advent Health for medical clearance, then to the inmate facility.

Both had left prior to our arrival, but were seen driving a Grey Chevy Equinox. There is an active no contact order in place from S1 being arrested a few days earlier. Sgt. Tietje spotted the vehicle at Long Creek Preserve, and saw a female walk into the woods. Other units responded and S1 and O1 were located in the woods together. S1 was arrested for violation of pre-trial release for having contact with the victim.
