<b>Disturbance-Domestic</b>	19-15421	Upsala Place	O1 and her mother O2 were involved in a verbal disturbance over custody of daughter. O1 has full custody, but O2 did not want her to take her. O1 packed some things and left with daughter.
<b>Criminal Mischief</b>	19-15453	Reidell Lane	When V1 went out to his 2017 Ram pickup, he noticed he had a flat tire and damage to his paint. V1 viewed his video surveillance and discovered a male in his driveway, he takes something and stabs the tire. He then hits the truck with the same object.
<b>Baker Act</b>	9-15448	Buttermilk Dr	The above listed address is a group home, and a juvenile was acting out in rage. He was restrained by staff members and taken into custody by LEO reference a BA.
<b>Disturbance-Domestic</b>	19-15501	Burning Wick Pl.	V1 called and advised he, his significant other, and her son S1 all reside together at this location as a family unit. S1 was not following the rules of the house, so V1 took S1 cell phone out of his hand. S1 then picked up a baseball bat and chased after V1. S1 mother stepped between the 2 and V1 was able to take the bat away from him. S1 was determined to be the primary aggressor, and placed under arrest reference Agg. Assault-DV.

Domestic disturbance caused V1 to get knocked off balance and caused her to fall, banging her head on the counter. V1 then told S1 to leave, which he did and she drove herself to AHH, where she received multiple staples for her wound.
