18-30010	Larceny	Audubon Way	V1 advised an unknown person(s) by unknown means stole a small European Fan Palm Tree in a 4-gallon pot, between 8:00 A on 3/29 and 8:00A on 3/30.	
18-30145	Disturbance with Weapons	CORD 330 E	Verbal altercation between two males during which time S1 allegedly brandished a firearm. V1 could only describe the firearm as being black in color. Although S1 owns several firearms, he denied brandishing a firearm during this altercation. Due to a lack of witnesses and the conflicting accounts of the incident, it is unclear at this time if any criminal actions had occurred; therefore, no arrests have been made. This investigation is still ongoing and charges may be filed at a later date.	
18-30064	Disturbance Domestic	Wilden Place	Physical disturbance between juvenile siblings. Step mom of the juveniles advised she and the juvenile's father will take care of the issue internally. Each identified the other as the primary aggressor. Due to lack of evidence and witnesses, no arrest have been made.	
18-30063	Suspicious Incident	Coolidge Court	RP (who is out of town) reported possible squatters staying at his residence. Units located an unsecured door on the rear of the residence (no evidence of forced entry) and conducted a protective sweep of the residence. No one was located inside or around the residence and there no damage inside the residence. However, several food and beverage items were identified as not belonging to the RP. The residence was re-secured and contact was made with several neighbors requesting they contact law enforcement if they observe any suspicious persons or activities around the residence.	
18-30134	Missing Person	Ulaturn Trl	DCF went to conduct a welfare check on a three week old infant at Ulaturn Trl, as they were going to shelter the child into their custody; however, once at the home they learned the mother, left the state with the child. Deputies made contact with The mother it was learned she was at exit 104 on 195 in VA. Contact was made with the Caroline County Sheriff's Office (VA). The Caroline County Sheriff's Office sent a Deputy to Mom's location and made contact with her and the child. Caroline County Sheriff's Office was put contact with DCF. Caroline County Sheriff's Office was going to contact their social services.
