Deputy Clay and Deputy Prather located the vehicle as it entered Flagler County on A1A. A traffic stop was attempted and the vehicle took off at a high rate of speed but was not pursued. The vehicle as spotted again on Palm Coast Parkway and FHP pursued the vehicle north on Old Kings Road, to US1 and then south on I95. FHP pursued the vehicle until it crash into the intercostal waterway behind 100 Lambert Ave. S1 and S2 were taken into custody as they were swimming to shore.
