He advised he arrived at the location yesterday (7/19) and observed someone had cut the electrical wiring out of the residence. RP stated he did not have time to wait for law enforcement yesterday so he reported the incident today. RP stated the theft of the wiring occurred sometime within the last 2 weeks.
