Burglary Residence	19-69988	Louisiana Drive	Neighbor reported a burglary in progress. Deputy Lentino arrived on scene and made contact with white male, later identified as S1. S1 got into a red Dodge utility vehicle while disobeying verbal commands, proceeded to back out of the driveway and flee on Matanzas Parkway. A pursuit was authorized after units at the residence confirmed a Burglary occurred (glass window shattered). Fireflight was requested and responded to the area. The suspect vehicle traveled southbound I-95, getting off at Palm Coast Parkway (westbound). Cpl. Gimbel and Sgt. Biss pursued the vehicle (w) Palm Coast Parkway, (n) Belle Terre Parkway, Braddock Lane. Pursuing Deputies were able to obtain a temporary tag, (# CMB6340) which came back registered to Justin Aldrich, address of 269 Beachway Drive. Due to the updated information and the safety of the public, the pursuit was terminated. Deputy Wood located the vehicle on Palm Coast Parkway. Deputy Wood followed from a distance while Fireflight was re-activated. The vehicle was observed pulling into the Palm Coast Post Office. Deputies responded after S1 exited the vehicle and was standing in parking lot. S1 was placed under arrest without incident. He was transported to FHF for a laceration to leg caused by glass from residential burglary. Vehicle was towed to FCSO impound for processing. S1 charged with Burglary, fleeing and elude, and resisting without violence.
Death	19-69926	Riverview Bend	RP called in advising her 81-year-old husband was not breathing and appeared to be blue in color. Med units arrived on scene and confirmed sig7. The male had a lengthy medical history and has been very ill and in a lot of pain recently. The death appeared to be natural with no suspicion of foul play. Report made Deputy Held.
Disturbance Domestic	19-69981	60 Memorial Medical Parkway (Advent Health)	V1 reported that her boyfriend, S1, struck her on her left arm three times with his fist during an argument while she was getting treatment in the hospital. She screamed for help. S1 fled from the hospital. Deputy Beane located the suspect in Town Center. He was arrested for domestic battery and transported to the inmate facility.
