Domestic Disturbance	19-63114	Zither Ct	Victim (V1) requested a civil stand by while she gathered her belongings from her live in boyfriend, (S1). It was discovered that last night S1 and V1 were involved in a verbal argument that turned physical when S1 grabbed V1s arm leaving a large bruise. V1 left the residence when S1 went outside to have a cigarette. S1 and V1 are in a relationship over the last two years and have been living together as a family unit for the last year. S1 was subsequently arrested without incident and V1 was able to gather her belongings safely. See report by Deputy Carter for further.
Domestic Disturbance	19-62955	Wellstone Ln	3rd party RP called to advise of a domestic altercation at the above residence. Upon LEO arrival, O1 had left the residence in a vehicle. O2 advised O1 pushed her onto the couch during the dispute. A short time later, the vehicle O1 was driving was located and followed by LE, which returned to the residence, after speaking with him, he advised his wife and he were arguing, when she punched him in the face 3 times and pushed him. It was determined O2 was the primary aggressor and she was placed under arrest reference DV Battery. See report by D/S Varnes.
Larceny-Shoplifter (Grand Theft)	19-63212	SR 100 E (AT&T)	2 unknown black males entered the AT&T store at this location and grabbed multiple cell phones and tablets from the display area and attempted to flee the store. Multiple witnesses were on scene. One citizen grabbed one of the subjects and held him until an employee advised him to let the suspect go for safety reasons. Both males then exited the store with the stolen electronics and fled the scene west on E SR 100 in an unknown white 4 door vehicle. The vehicle then made a uturn and headed west on E SR 100.
