<b>Larceny</b>	19-85802	Washburn Place	RP stated she was mowing her lawn, and stopped to talk with a neighbor. The mower was left on the side of the yard (Wasserman Drive side). Approximately twenty minutes later, she noticed the mower was missing.
<b>Suspicious Incident</b>	19-85706	Raintree Place	O1 was found unresponsive laying on the sidewalk in front of the residence. O1 was transported to Advent Health then air lifted to Halifax. While clearing the residence, a small marijuana grow operation was discovered. ISD, CSI notified and responded.
<b>Verbal Disturbance</b>	19-85808	Kindswood Drive	A verbal argument over a parking space occurred at the gas station. An unknown male threatened to shoot the other party and both parties left the scene prior to LEO arrival. Contact was made with one half of the disturbance at McDonalds near Old Kings/SR 100, O1 and O2. They stated that the unknown male was arguing with them about a parking space and stated that he would shoot them if they followed him. No weapon was displayed, which was confirmed by witnesses and video surveillance from the store.
<b>Burglary Vehicle</b>	19-85751	Relay Road	RP advised her unlocked vehicle was broken into overnight and that nothing of value was taken. RP only wanted contact by phone and stated that she did not want to file a police report.
<b>Stolen Vehicle Recovered</b>	19-85731	S US1	FCSO located a stolen Suzuki SUV Southbound on US1. The vehicle made a U-Turn and pulled into Bunnell Gas where FCSO performed a felony stop. S1 was listed as the suspect in the FCIC/NCIC hit and the driver of the vehicle, S2, had text message communications with S1 about buying the vehicle from her and also had possession of the title to the vehicle. S2 provided us with S1 location at the Econo Lodge in Ormond Beach which was relayed to VCSO. S2 was arrested reference driving while license suspended with knowledge.
