18-87542	Assist Other Agency	815 E Moody Blvd (Betty Steflik Park)	Deputies assisted Flagler Beach Police Department with an armed suicidal person in the park. A male called stated he was armed and wanted to commit suicide. The male stated he collapsed and could not get up. The location of the male was unable to be determined. Fire Flight responded and assisted in locating the man in the woods. Deputies and Flagler Beach PD created a contact team. Fire Flight directed the contact team to the male. The man was taken into custody without incident and was found to be in possession of a firearm and several rounds of ammunition.
18-87532	Domestic Battery	Wesbriar LN	During an argument S1 scratched her boyfriend on the nose causing it to bleed. S1 was subsequently arrested
18-87529	TS	Interstate 95 S @ mile marker 293	Deputy Dawson conducted a traffic stop for speeding and made contact with the sole operator of the vehicle, S1. S1 had an out of county warrant which he was subsequently arrested for. During an inventory of the vehicle, 19 grams of cannabis was located; S1 was also charged with possession and transported to the inmate facility without incident.
18-87540	Crash hit and run with injuries	PCP @ Pine Lakes Pkwy	Units responded to a hit and run where a blue truck took off at a high rate of speed and ultimately crashed on Old Kings Rd. Units set a perimeter and fireflight assisted in checking the woods. K9 deployed on lead due to subjects being transported to the hospital. A suspect was developed, S1 and units conducted surveillance on his last known residence. A silver vehicle returned to the residence and contact was made with S1 mother who invited deputies in and allowed them to check the residence. Contact was made with S1 in a bedroom where he was secured without incident. S1 was transported to FCIF.
18-87539	Larceny Shoplifter	10 Garden St N (Home Depot)	A customer advised that a white male, bald with tattoos, possibly stole a generator and took off at a high rate of speed in a blue crossover, bearing FL IB42EZ. Contact was made with Home Depot who advised that they were unaware of a larceny and the LPO was not on scene. Deputy Lentino continued to make contact with management and LP and they were able to access the cameras and confirm a larceny occurred, multiple items totaling \$1,196 were recovered. Deputy Scalia was able to positively ID the subject as S1.

S1 was arrested on the above crash and was additionally charged with retail theft. Juvenile female detained under a baker act and transported to HBS by night shift.
