Assist Other Agency	19-90695	Harbor Village Point (Yacht Harbor)	Units responded to this area in reference to a possible fuel leak from a vessel docked there. Investigation revealed all fuel was contained within the vessel itself and none had leaked out into the water. Flagler County Fire Rescue and FWC determined there was no environmental impact. The Florida Department of Environmental Protection was notified.
Burglary Vehicle (Attempt)	19-90701	Plumtree Place	<p>What appeared to be a black male with blue shorts and a brown hoodie was observed on video surveillance attempting to enter vehicles in the driveway at 5:10am. Contact with juvenile S1 was attempted at 28 A Plateau Lane but he was not home, however contact was made with his mother and family. Video was shown to them and the incident was explained. His mother picked him up and arranged an interview. Full confession was obtained for the vehicle burglaries and S1 showed which vehicles at each residence that he attempted to enter or did enter. Stolen Vehicle	19-90732	Sea Breeze Trail	Gray Dodge Ram 1500 bearing Florida handicap tag YN44J taken overnight during a house party at the location. Vehicle entered into FCIC/NCIC as stolen. Report made by Deputy Doggett
Larceny	19-90692	Plateau Lane	Arlo camera taken off of the front of the residence. Brief video showed the camera was removed but did not point at the suspect. Report made by Deputy Gossett
Assist Other Agency	19-90721	N. State St.	A stolen vehicle was located by FCSO units traveling southbound on US1 towards Bunnell. FCSO assisted with a felony stop. The driver (S1), who was listed as the suspect in NCIC, was detained. Since Bunnell PD was the originating and entering agency, the
