Types of Cases Appropriate for Services

- Physical Abuse
- Sexual Abuse/Assault
- Exposure to Domestic Violence and Substance Misuse
- Malnutrition and failure to thrive
- Medical, physical or emotional neglect
- Child death as a result of abuse/neglect
- Witness to a crime
- Children at high risk for abuse/neglect

Counseling Services

- Victims of Crime Act- Compensation
- Child Victim Rapid Response Program "Rapid Response"
- Sexual Abuse Treatment Program (SATP)
- Physical Abuse and Domestic Violence

Exposure to domestic violence, in itself, is a form of child abuse

"Harm to a child's health or welfare can occur when any person:...

(i) Engages in violent behavior that demonstrates a wanton disregard for the presence of a child and could reasonably result in serious injury to the child.

(j) Negligently fails to protect a child in his or her care from inflicted physical, mental or sexual injury caused by acts of another

Florida Statutes 39.01(30)

Domestic Violence Affects Children Because.....

- When adult spouses are abused, children are likely to be abused too
- Children who witness domestic violence are likely as adults to continue the cycle

-Boys may grow into men who abuse their partners

-Girls may grow up expecting to be abused

Risk Factor in Child Death

According to State of Florida Abuse Death Review Committee. Annual Report, December 2011:

- Top 5 perpetrator risk factors in child deaths:
- Substance/Alcohol Abuse History
- Prior History with DCF
- Criminal History
- Domestic Violence
- Mental Health Diagnosis

Domestic Violence

Domestic violence is discussed with each child and family regardless of allegations that prompted CPT involvement

Adults typically minimize; children may be protective of parents.

Children more likely to accurately describe home life than parents. Especially if not aware that anyone is concerned about domestic violence.

Goals of the OVW Grant

- Create awareness programs for the campus community to reduce the four crimes classified as Violence Against Women Act (VAWA) crimes:
 - Sexual assault
 - Domestic violence
 - Dating violence
 - Stalking/Cyberstalking
- Develop relationships with community partners to provide victim services
- Work with College Administration to improve policies and procedures as they pertain to the VAWA crimes & student conduct

What is Stalking?

- <u>General definition of stalking</u>: "A pattern of behavior directed at a specific person that would cause a reasonable person to feel fear for their safety or the safety of others; or suffer substantial emotional distress" (SPARC, 2022)
- Stalking is a crime in all 50 states, the District of Columbia, and U.S. territories, but definitions of stalking may differ by state
- 2021 Florida Statutes:
 - In Florida, "a person who willfully, maliciously, and repeatedly follows, harasses, or cyberstalks another person commits the offense of stalking"

Is It Stalking?

- Stalking differs from harassment, although harassment can be part of the stalking pattern
 - Individuals who experience harassment typically are not afraid of the perpetrators
- Individuals who are being stalked are more likely to report experiencing <u>fear</u> and often <u>make changes</u> in their lives to avoid their stalker
 - Anger, irritation, and minimizing the behavior may indicate fear
- With stalking, the <u>context</u> matters:
 - Stalking behaviors may have symbolic meaning to the victim
- Stalking is often minimized and normalized in the media
 - Stalking behaviors are portrayed as "romantic"

Stalking Behaviors

- Stalking is a pattern of behavior
- Stalkers often engage in multiple stalking behaviors when stalking their victims
- Examples of common stalking behaviors (SPARC 2021):
 - Unwanted contact
 - Following/spying on the victim
 - Sending the victim unwanted gifts
 - Tracking the victim through technology
 - Hacking the victim's online accounts
 - Showing up/waiting for the victim
 - Damaging the victim's property
 - Spreading rumors about the victim
 - Harassing co-workers, family, and/or friends of the victim
 - Threatening to harm the victim or those close to the victim




Prevalence of Stalking

- Individuals between 18-24 experience the highest rates of stalking among adults (SPARC, 2021)
 - The rates of cyberstalking for this age group are almost twice as high as the rates for other adults
- At Daytona State College, stalking makes up the majority of cases of interpersonal violence (DSC, 2021)
- It is estimated that the majority (up to 70%) of stalking victims do not report the stalking to law enforcement (Morgan & Truman, 2022)

How Can You Help Someone Who is Being Stalked?

- Listen and believe them
- Remind them that the stalking is not their fault
- If approached by the stalker, avoid sharing information about them
- Encourage them to document all stalking behaviors
- Encourage them to create a safety plan
- Encourage them to seek local support:
 - Victim service providers
 - Campus Safety and/or Law Enforcement
 - Injunction for protection
- Check in with them frequently
