Some Personal Information

I was born in Portland, Maine and grew up in a suburb of St. Louis. I have 3 children and 5 grandchildren. After an early marriage ended, I became a single parent, raising 2 of my kids on my own. I played competitive softball until the age of 64. I am now an avid golfer and bowl in 2 leagues. Military

1970 - 1991

- When I was 20, I joined the United States Army, and served for over 20 years. During this time, I served four tours in Germany and one tour in South Korea.
- As a non-commissioned officer, I held many positions of authority in both Germany and South Korea. I served in the Military Postal System as an Operations NCO, COPE (Custodian of Postal Effects), Physical Training Instructor, Weapons Instructor, Urban Tactical Instructor.
- While in Germany, I was tasked by the "U.S. Army Postal Group Commander" to consolidate the cities of Frankfurt, Geissen, and Hanau postal units into one postal finance unit. I received an award for successfully accomplishing this task.
- My last duty was at Fort Ord, California. I was Chief of Admin for the Directorate of Reserve Component Support. I handled the finance and personnel records for Army Reserves and National Guard that came to Fort Ord for training.
- Along the way in my career, I was also a U.S. Army Recruiter, helping to recruit young men
 and women to serve our country. In addition to working in a recruiter's office, I also went to
 high schools to speak to gymnasiums full of soon-to-be graduates about the benefits of
 becoming part of our military.

- During my entire military career, I was known for making good, sound decisions, adding valued improvements to operational systems.
- As part of my postal duties, I was responsible for millions of dollars and equipment. At any
 one point in time, I had control of over \$20 million dollars on a daily basis.

I retired from the Army in 1991.

United States Post Office 1993 - 2012

After retiring from the military, I worked 19 years for the United States Postal Service as a Letter Carrier and Carrier Technician. As opposed to a Letter Carrier, a Carrier Technician position that requires knowledge of five different routes, so every day was a different route to service.

I retired from the Post Office in 2012.

Farm & Home Supply, Cottleville, MO 2018 – 2020

Farm & Home Supply is a chain supplying farm, home, and livestock needs, plus sporting goods and lawn equipment.

I started part-time in the Power Equipment Department, performing sales of chain saws, trimmers, zero-turn lawn mowers, and all power equipment related products. I also sold firearms in the Gun Department. After that, was promoted to Department Manager in the Tools, Hardware, and Automotive Departments. When I went to those departments, I began working full-time. I was later promoted to Department Manager for the Power Department, filling an opening that occurred.

Service to Palm Coast 2021-2025

After moving to Palm Coast, my wife and I began attending Palm Coast City Hall meetings, and decided we should get involved wherever we could. My involvement includes:

- The Citizens' Advisory Committee representing Palm Coast with the Volusia-Flagler TPO, appointed by the Palm Coast City Council.
- Member of the Palm Coast Code Enforcement Board, appointed by the Palm Coast City Council.
- Member of the Palm Coast Planning Land Development Regulation Board (PLDRB), appointed by the Palm Coast City Council. Resigned my previous appointments (required by Palm Coast) in order to serve on the PLDRB.

• Ran in 2024 for the 3rd District City Council position, and lost by only 2 votes to Ray Stevens who subsequently won the race. I then supported Ray's run and helped him win over this other competition.
