Former Chairman of the Grand Haven CC Board of Governors and was the Chairman of the Flagler County Republican Executive Committee (FCREC) through 2014. Elected as the Flagler County Commissioner District 3 in the November 2016 General Election and re-elected for four more years in 2020. Served as Chairman of the BOCC and retired in November 2024.

Married to Patricia Perry Sullivan who was born in Jacksonville and sadly passed away in 2019. Son Commander Sullivan, a Naval Aviator, retired from the Navy in September 2014 and now lives in Virginia with wife Tricia and their three children and is a pilot for Delta Airlines.
