I believe I meet and exceed the education and experience sought for the position.

I have a *jurist doctorate* degree from the Albany Law School of Union University, which is a nationally accredited law school.

I am admitted to practice law in the states of Florida, Michigan and New York and am in good standing with all three bars, never having been the subject of an inquiry. I am also admitted to practice law in the US District Court, Middle District of Florida.

I am primarily a people person. I can work with a broad array of people from diverse backgrounds and can find common ground and experiences with most people. I have been especially successful working within an institution, such as a city or town government; and, reaching accords in alternative dispute resolutions, such as mediations.

I have over 30 years' experience as a practicing attorney with extensive civil litigation experience, including jury trial and appellate experience. I am a former prosecutor and served as an Assistant District Attorney, Rensselaer County, New York.

I also have extensive experience in contracts, real estate, procurement, employment, and election law. This experience has been acquired both in my private law practice, and my government employment.

I am currently self-employed and have a general practice of law, specializing in choice/conflict of laws. These matters involve clients that reside in one state (such as Florida, Michigan or New York), but have legal issues involving another state. Many times, they also involve municipalities and access to government documents (NYS FOIL laws/Florida Sunshine Laws).
