Mr. Rick,

This is Matthew Everett on 612 Shearwood Drive. Prior to placing the two retention ponds on our lot, I spoke to the city engineer in person. I had some concerns about the placement of the retention ponds that were recommended. I asked him "what can we do about the flooding problem on our lot?" He was condescending, short and provided no solution for the present problem. I attempted to show him pictures of the flooding on the lot, he refused to look at them. When I asked him "What can we do?, with a harsh and abrasive tone he replied, "What do you want me to do about it? What would you suggest we do to fix the problem?" Then he went on to say "that's how it always has been and that's the way it will always be." He advised me that this is my problem, not the city's. The city engineer suggested that we dig more retention areas, therefore making more of our property useless.

I attempted to explain to him how water runs off of Palm Ave, onto Shearwood and onto our lot. All of the lots around us are higher than us. The water has only one place to go...our property. During times of heavy rain, we are unable to drive some of our vehicles on the driveway. The water covers a ½ of our lot and flows over our bulkhead which dumps into the canal. Due to the water run off, not only are we having structural compromises to our bulkhead, but our neighbor is as well.

Currently, the two retention areas that we were instructed to place remain dry while ½ of our lot remains flooded during heavy rainfall. I have photos and videos of the flooding. Is it possible our neighbors and I can meet with you to discuss a solution? Your help would be greatly appreciated.
