#### 4. Project/Program Description

As a result of past hurricanes and damage to A1A, beaches and property along the coast, Flagler County has developed a comprehensive Beach Management Plan for Flagler County's Atlantic Ocean coastline. This study includes an 11.6-mile stretch along the coastline that must be considered for preservation. This will be in addition to the US Army Corps project and additional assistance from FDOT. As part of the study, current sand loss, location of sand sources, loss of sand from future storms and sea level rise and required sand volume needed to construct and maintain the Flagler County Atlantic Coastline have all been considered. This project will complete the full 18 miles of coastline for restoration of sand loss and to stabilize the coastline from future impacts.

#### 14. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

This project will include completing the replacement of sand loss along the 18 miles of Flagler County coastline. This will provide a resilient coastline, protect life and property including A1A from future impacts and give Flagler County the time needed to implement a six-year interval management and maintenance plan.



#### b. What activities and services will be provided to meet the intended purpose of these funds?

Replacement of current sand loss to complete the project to restore the full 18 miles of coastline so that Flagler County can move to management and maintenance for future resiliency.

#### c. What direct services will be provided to citizens by the appropriation project?

This project will complete restoration of the beach and dunes which will protect the upland infrastructure including SR A1A; enhance and protect the environmental habitat; and restore and maintain the recreational access and use of the beach, an important economic resource for the County along the eighteen miles of shoreline.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

This project will benefit all residents of Flagler County whether they live near the beach, use the beach or have a tax benefit as a result of tourist visits. There are close to 130K residents that will have a direct benefit from this project but with more than 1,000,000 tourists annually that significantly increases the benefit not to mention the financial impact as a result.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The addition of sand to reconstruct the dune and beach will increase beach and dune elevations and will save lives and protect properties during future large storms and hurricanes. Roadways will not flood and stormwater management will be improved by limiting the amount of flooding. This will also have a positive impact on recreation, tourism, economic activity and will provide many health benefits as a result of replacing sand loss.
