## 4. Project/Program Description

Construction of a new 10,000 sq. ft. Eco-Discovery Center which will be located on a 22-acre county owned parcel on SR100 along the Heritage Crossroads Byway and approximately 1 mile east of I-95 and 3 miles west of A1A Scenic & Historic Coastal Byway in Flagler Beach. This location is also approximately .25 miles from the newly constructed pedestrian bridge and adjacent to the future Bulow Creek Headwaters Regional Park. This conservation and educational center will act as the main hub in Flagler County to protect, conserve and enhance recreational, natural, historical, and cultural resources.

Construction of the Flagler County Regional Conservation & Eco-Discovery Educational Center will further support the goals, objectives, and strategic priorities of Flagler County, Northeast Florida Regional Council, and the Scenic A1A Byways. The Eco-Discovery Center aims to provide unique, immersive, and educational experiences for nature and cultural heritage enthusiasts, families, and educational groups while increasing economic activity, job creation, and enhanced quality of life.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Construction of a new 10,000 sq. ft. Eco-Discovery Center will be situated in an ecologically significant part of the county, and will offer interactive exhibits, guided tours, recreational services (biking, hiking, birding, kayaking, wildlife viewing) and various revenue streams It will support local entities regionally and provide information, education, and interpretation of local resources.

#### c. What direct services will be provided to citizens by the appropriation project?

The Center will be the main hub for regional ecotourism information to provide experiences for recreational and educational opportunities. Facility will also include indoor/outdoor event space for rental opportunities that will fill a gap in the community as indicated in a recent study. Connectivity and access to future Bulow Creek Regional Park, new pedestrian bridge, and existing trails.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

All county residents (130K) plus tourists visiting the area. There are currently millions of tourists that come to the Sunshine State each year. The new Eco-Discovery Center will be 30 minutes from Daytona and St. Augustine. These two cities combined host well over 17 million tourists each year. Since the Center will be located right off I-95, they could tap into the millions of tourists already coming to the area.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The center will improve the physical health of the public through offering various eco-tourism experiences including hiking, biking and kayaking. This would be measured through the number of people coming to the center and requesting information on these activities. It will also improve transportation conditions into Flagler Beach through offering a shuttle service from the center to the beach area. This will be measured through the number of riders. Finally it will increase economic activity and tourism for Flagler County and local businesses through supporting and advertising of the local businesses at the center. This will be measured by the number of tourists visiting with hotel stays and the number of businesses indicating increased traffic and sales as a result of the promotion.
