I continue to have business commitments, but they now require less of my time than in previous years.

- **Listener** I long ago taught myself to listen to what someone is saying and not how they are saying it. I listen actively letting the communicator know that I have received the message that they sent.
- Communications I write well and speak clearly. I Can usually summarize complex sounding issues into more understandable points. I Can usually be tactful even when saying no.

**Education** – BS in Business Management in 1969 from Fairleigh Dickinson University in Teaneck, NJ. Done while working full time days. Later, in Fresno, CA started an MBA and completed 30 credits again at night. Promoted by Crocker Bank out of the area and never completed the MBA.

**Experience** – To illustrate my understanding of and adherence to laws: I was a Military Policeman in the Army and spent over a decade as a youth soccer referee. I also coached youth baseball and soccer. I have been licensed in California and Florida to sell Life Insurance, Health Insurance and Annuities. Compliance is an absolute must to maintain one's license.

Spent 14 years in commercial banking, mostly as a Vice President and Branch Manager. Extensive experience in many types of commercial lending. Spent 15 years in cash flow consulting to small businesses. Was then hired by a client to become the CEO of a small credit union. Afterwards, joined Washington Mutual in business lending. After that era, began selling health insurance and Medicare plans in California.

Continue those insurance activities to this day in the ten years since moving to Florida. Was a member of the Flagler County Republican Executive Committee for seven years under four chairpersons. Chaired the Audit Committee for three of the last four years during which I was a member. Have followed local and national politics closely.

**Talents** – Analytical, objective thinker. I look beyond the obvious and keep an open mind to internalize information from varied and nontraditional sources. It is not unusual for me to think out of the box. My sense of humor can sometimes help defuse situations that might otherwise be more difficult to negotiate.
