I collaborated with the Florida Department of Transportation (FDOT), Federal Transit Administration (FTA), Federal Highway Administration (FHWA), and local government officials on transportation issues throughout Marion County.

As project manager, I led the 2045 Long Range Transportation Plan (LRTP), which included overseeing the Central Florida

Regional Planning Model (CFRPM) for forecasting growth and traffic patterns. I reviewed transportation planning documents and comprehensive plans to align TPO planning programs with local government objectives. I ensured the Transportation Improvement Program (TIP), List of Priority Projects (LOPP), and Unified Planning Work Program (UPWP) met all United States Code (USC), Code of Federal Regulations (CFR), and State Statutes requirements.

I managed the TPO's grant portfolio, including: FHWA Planning grant (\$800k), FTA's 5307 grant (\$2 million) for SunTran public transportation, FDOT Block Grant (\$200k), 5305d grant (\$98k), and Transportation Disadvantaged grant (\$26k). For SunTran, I handled 5307 award applications and completed all required reporting, including National Transit Database (NTD), Milestone Performance Reports (MPRs), and Federal Financial Reports (FFRs). Throughout my tenure, I served as Fiscal Manager, Senior Planner, Interim Director, and Assistant Director.

I led the development review committee for the City of Kissimmee, overseeing the review and approval of land use, zoning, fire, and building code for new and existing developments. I collaborated directly with local, state, and federal government officials to address critical land use and economic development issues.
