Effective immediately, you are placed on **Administrative Suspension with Pay**. While on Administrative Suspension, you will follow the below listed orders:

- You are directed not to perform in any official law enforcement capacity and are not allowed
  to wear any FCSO uniform or dress that identifies you as an FCSO employee, except by
  subpoena. You will be subject to the same codes, laws and ordinances as are citizens.
- During the hours of 0830 1630 hours (Monday through Friday), you will remain at your residence and available for contact by FCSO Supervisors or IAU Deputies.
- If you need to leave your residence for any reason between the hours of 0830 1630 hours (Monday through Friday), you must notify your Division Commander, or their designee, to request their permission to leave your residence. If you wish to take time off, you need to contact your Division Commander, or their designee, for their approval.
- You are not permitted to be on FCSO property unless accompanied and approved by your Division Commander or their designee.
- If directed to appear at an FCSO building, you will be accompanied by an FCSO Supervisor or deputy from the IAU while inside the building.
- The following FCSO items shall be surrendered to your Division Commander or their designee upon suspension. A Receipt of Departmental Property (IA-TBA) will be completed and a copy provided to you: Mandatory Items

Failure on your part to adhere to the requirements of this order will be considered insubordination for which you will be subject to disciplinary action.

#### **MEMORANDUM**

Recommendation of Internal Investigation/Dep. J. Vazquez

Commander Cole has obtained information from Special Agent Supervisor Josh Mead from the Florida Department of Law Enforcement (FDLE) in reference to some alleged behavior or D/S Julio Vazquez that will need to be further investigated by the Professional Standards Unit.

Commander Cole has learned that sometime Friday, 1/20/17, sometime prior to 6:00am (shift change) D/S Vazquez had contacted D/S Johnathon Vitale by telephone. D/S Vazquez was giving D/S Vitale a "heads up" that FDLE was conducting a criminal investigation at the Flagler County Inmate Facility. D/S Vazquez advised D/S Vitale to let D/S Gilyard know what was going on. D/S Vitale and D/S Gilyard were scheduled to work together this shift guarding an inmate in Volusia County. Earlier in the shift Cmdr. L. Miceli made contact with all personnel on-duty, to include D/S Vazquez, and advised them not to talk to anyone about FDLE being at the facility.

Commander Cole has additionally learned that FDLE interviewed Inmate Cheryl Folta (W/F 10/24/66) in reference to their investigation. Inmate Folta advised that she is assigned to laundry duty and on Friday 01/13/17 she was contacted by D/S Vazquez and D/S Vazquez told her that she needed to call in sick on Monday 01/16/17. D/S Vazquez advised Inmate Folta that D/S Gilyard was going to have sex with Inmate sometime on Monday 01/16/17 in the laundry room.

Inmate Folta additionally described an incident several weeks ago involving D/S Vazquez inappropriately touching her. Inmate Folta advised that she was putting away laundry in the supply room in the booking area. Inmate Folta advised that D/S Vazquez came into the room and began to fondle and kiss her. Inmate Folta denies having any sexual relations with D/S Vazquez. A review of video of several shifts worked by D/S Vazquez depicts on multiple occasions D/S Vazquez does enter this supply room in booking several times when Inmate Folta is putting away laundry. This particular supply room is not covered by video and it is a violation of policy for a male office to be in a room solo

in an area not covered by video.

On Monday January 23, 2017 Cmdr. Miceli made contact with D/S Vazquez prior to his shift starting at 6:00pm and collected Deputy Vazquez's equipment (badge, Taser, firearm, etc.) and he was put on paid administrative leave.

At this time Chief Cole is recommending that this matter be referred to the Professional Standards Unit for further internal investigation.
