When I was in the hospital they never told me what had happened to him, they only told me he was at a different hospital, and all I could think about was if he was okay or not. When they finally told me what happened I went into a huge depression and cried for a very long time, I know that I will never feel your pain but I had pain from this because my whole life I tried to make everyone happy and to see what I had done and how it hurt an entire family, it made me very disappointed in myself. Lately all I can think about was the accident and Logan. For days on end I prayed and even wished that I could have gone back and traded places with Logan because I know he had so much to offer to this world. I really hope that one day you can forgive me for what has happened. Also I am sorry for not contacting you sooner Robert, I was scared to reach out which is why I always talked to Norma and I was hoping she was telling you what was being said. Still to this day I pray for your family. I hope that you all heal from this, I know its going to take time but I will keep praying for your family as I am deeply sorry for everything.

**PLEA TENDER**

I, JOEY RENN, having been charged in the above-named case with: VEHICULAR HOMICIDE, do hereby tender to the State an offer to plead NO CONTEST and request that the State agree to a proposed sentence of:

Withhold adjudication; 2 years of community control followed by 10 years of probation; No possibility of early term for the community control; Special conditions of supervision include completion of the 12 hour drivers instruction class, the Victim Awareness Panel, Mental Health Evaluation & completion of any recommended treatment, 200 hours of community service to be completed at a rate of at least 5 hours per month, Defendant shall maintain full time employment or a full-time academic load or some combination thereof, Defendant is prohibited from owning or driving a motorcycle for the duration of his supervision, No drugs or alcohol, RUAs, Standard costs and fines.

I am making this offer in furtherance of plea negotiations as part of an attempt to resolve the above-named case and make said offer with the understanding that it will not be used against me in this or any future proceeding.
