[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 2nd day of April 2010, at approximately 0430 [xxx] A.M. [] P.M. at 200 block Commercial Drive within St. Johns County, violated the law and did then and there: Participate in the Kidnap and Murder of the victim, Vincent Binder which was motivated by financial gain. On 3-30-10 the defendants; Kentrell Johnson, Quentin Truehill, and Peter Hughes escaped custody at the Avoyelles Parish Sheriff's Office in Marksville, Louisiana. During the escape the defendants injured a Correctional Officer. The defendants ultimately stole a 2006 Chevy 2500 pickup truck and began traveling toward Florida. The defendants have been linked to numerous acts of violence along the route from Louisiana to Florida. The defendants were linked to acts of violence (robberies) which occurred on 4-1-10 in Tallahassee, FL. The victim was reported missing by friends to the Tallahassee Police Department and Vincent Binder's financial records were investigated. It was discovered Vincent Binder's bank card had been used at numerous locations along the I-10 and I-95 corridor between Tallahassee, Florida and Miami, Florida. The investigation revealed a link between the use of Vincent Binder's bank card and the escaped prisoners based on video captions of transactions. The stolen vehicle the escapees were known to have been traveling in was located in the Miami, FL area. Evidence was located in the recovered stolen truck including receipts for Vincent Binder's bank card and a knife with blood on it which has been confirmed to be that of Vincent Binder. Kentrell Johnson, Quentin Truehill, and Peter Hughes were located and taken into custody by US Marshals in Miami, FL on

4-12-10 for the escape. Clothing items were located at the time of the defendant's arrest which have been found to have Vincent Binder's blood on them as well. Detective Anne Johnson of the Tallahassee Police Department interviewed Kentrell Johnson after his arrest in Miami, FL. During the interview, Kentrell Johnson states Vincent Binder was killed in an open field and he eventually provides investigators with an additional description of the area where the homicide occurred. Kentrell Johnson also stated Vincent Binder made multiple pleas to be released during the trip between Tallahassee and St Augustine. On 4-28-10 partially decomposed human remains were located in an open grassy field at 200 Commercial Drive St. Augustine, FL. Dr. Frederic Hobin performed an autopsy on the human remains during which the remains were positively identified as Vincent Binder. Dr. Hobin certified the cause of death being multiple stab wounds and or blunt force trauma described as "Homicidal violence" and the manner of death to be Homicide. Dr. Hobin noted numerous points of "defensive type" wounds on Vincent Binder's hands and arms.
