The role of the Managing Entity is to bring together community stakeholders and assess, plan, allocate and monitor the use of state and federal funds, to leverage local resources and to bring additional resources to the system to effectively meet the unique and specific behavioral health needs of our 23-county service area. LSFHS promotes and supports the development of holistic, innovative and evidence-based programs within a strength-based, recovery-oriented system of care.

LSFHS serves a diverse area that encompasses rural, suburban and urban communities. Counties served include Alachua, Baker, Bradford, Citrus, Clay, Columbia, Dixie, Duval, Flagler, Gilchrist, Hamilton, Hernando, Lake, Lafayette, Levy, Marion, Nassau, Putnam, St. Johns, Sumter, Suwannee, Union and Volusia counties.

## **OUR ACCOMPLISHMENTS**

- LSFHS Administrative Rate is 2.64% of the \$247M annual budget.
- Through our robust care coordination efforts at both the ME and the provider level, recidivism rates for high utilizers of acute care services (crisis units, detox and jail) enrolled in our program have averaged 3-5%, far below industry standards.
- Co-located a family care coordination specialist in the children's crisis unit, which dramatically reduced the number of readmissions to the crisis unit. Children with 10-20 admissions per year have now been stabilized in the community with no new admissions.
- Established a toll-free, 24/7 ACCESS to CARE line, manned by our clinical team to assist with referral information.
- ROSC Peer Training Initiative LSFHS has developed, in partnership with the Florida Department of Children and Families and the federal Health Resources and Services Administration (HRSA), a stellar Peer Recovery Training program that has trained more than 300 recovery peer specialists to date and established one of the first behavioral health apprenticeship programs in Florida. Through funding from a competitive HRSA grant, LSFHS received designation as a registered apprenticeship site through the Florida Department of Education, Division of Career and Adult Education. Our apprenticeship program currently collaborates with key employers who run community-based behavioral health organizations and LSFHS provides support to those employers to retain peer staff. LSFHS is launching a specialized training program for veterans with lived experience who wish to earn the Certified Recovery Peer Specialists (CRPS)-Veteran designation. Following the completion of the training program, veterans will be assisted in connecting to employers throughout northeast and central Florida where CRPS-Veterans can play a critical role in the delivery of person-centered recovery support services.
- Project Save Lives LSFHS has been a partner in Project Save Lives, one of the first and most successful hospital bridge programs to address substance use disorder by bringing peer specialists into the emergency department to intervene when individuals present with an overdose. Reduced numbers of overdose deaths, EMT responses, emergency room admissions and endocarditis related to opioid use have resulted in hundreds of thousands of system cost savings.
- Established a Housing and SOAR Division to identify and secure housing options for consumers in our network of care.
- LSFHS has brought an additional \$17.4M in grant resources in fiscal years 2020-2023 to serve the individuals in need in our service area serving as the lead applicant or a partner in grant applications including Criminal Justice Reinvestment Grants, SAMHSA and HRSA federal grants as well as private foundation grants such as Florida Blue Foundation.
- Established the LSF Training Institute that provides a robust catalogue of trainings on evidence-based practices, peer specialist certification and trauma-informed care. The Institute provides CEUS for most disciplines.
- Beginning In 2019, LSF hosts an annual Innovation in Behavioral Health Summit, highlighting thought leaders and innovative practices.
- LSFHS has piloted a co-responder program with Meridian Behavioral Health and Gainesville Police Department that pairs a licensed clinician with a specially trained officer to respond to calls related to behavioral health. The program has resulted in 91% of individuals who could have been arrested being diverted and 79% of potential Baker Acts being diverted to outpatient or voluntary admission. The program has been replicated in other jurisdictions.
- LSFHS hosts numerous community summits including an annual Human Trafficking Summit, Rural Mental Health And Substance Misuse Summit and Uplift Putnam, Faith and Community Leaders Rallying Together for a Common Cause.
- LSFHS was awarded a \$1.8M grant to provide regional supports targeting behavioral health needs of first responders and their families to reduce the incidence of suicide or attempted suicide among employed or retired first responders. The pilot serves 20 counties in NE and North Central Florida in collaboration with 211 and two network service providers to provide information and referral and peer support services.
