Dear Members of Flagler County School Board,

Greetings to you all. I am a twelve-year resident of Flagler County and today I am writing to urge you TO NOT AMEND YOUR SCHOOL BOARD POLICY MANUAL REGARDING CHAPTER 5, LEGAL NAME OF STUDENT, CODE 529, STAUTORY AUTHORITY 1001.41 1001.42, F.S. LAWS IMPLEMENTED 1000.21 1001.43 1003.21, F.S., THAT MIGHT REQUIRE USING PRONOUNS MATCHING ANYTHING OTHER THAN THE GENDER OF THE STUDENT'S BIRTH.

Please note that from the 1980s through 2006, I was lesbian advocate for homosexual rights. I am a former member of the Human Rights Campaign; a former board member of the National Gay and Lesbian Task Force; a former member of the National Black Gay and Lesbian Leadership Forum; founder of In The Life Atlanta (an African American gay pride organization); and former publisher of VENUS, an internationally distributed lifestyles magazine supporting African-American lesbians and gay men.

In 2006 I had a radical change of heart when I finally humbled myself and submitted to the teachings of Jesus Christ, as revealed in the Holy Scriptures of the Bible. Since the day of my transformation, I have worked to lovingly share with anyone deceived by same-sex attraction or so-called transgenderism and their advocates that CHANGE is not only possible but EVIDENCED in myself and countless others who are experiencing complete freedom from our former same-sex or gender confused desires.

Because my perspective is unique as a former insider of the sexual rights movement, I am urging you to consider these points and "VOTE NO" TO AMEND CODE 529 OF YOUR POLICY MANUAL THAT MIGHT REQUIRE USING PRONOUNS MATCHING ANYTHING OTHER THAN THE GENDER OF THE STUDENT'S BIRTH.

There is no evidence genuinely supporting 'gender identity'. One is either born male or female. Homosexuals (when we refer to homosexuals, we include so-called transgenders and all other 'identities') and the liberal media are not interested in legitimate research such as the <u>accurately</u> <u>published study by Dr. Paul R.
