



## Centennial Celebration Logo Contest

### Official Rules

- Open to all legal residents of the U.S. 16 years and older.
- One entry per person.
- The logo must be original and unique.
- No third-party images should be used in logo designs (e.g., clipart, stock photos, stock designs).
- The words “Bunnell” and “Centennial” must be included in the logo design.
- Artwork must be in color with a four CMYK color limit, and also provided in black and white.
- Logos must be created in vector format in any size up to 8” x 8”. The final illustration must be executed on poster board (8 1/2 inches by 11 inches, in full color) and submitted electronically in a JPEG format 300 dpi.
- The submission may not contain images of living or deceased individuals without authorization, and by entering the contest, the competitor hereby represents that the competitor had authority to depict any individuals contained in the submission or that the likeness of such individuals is in the public domain, and the competitor hereby grants the right to the City to reproduce or display the submission without any duty to compensate the submitter or the individuals depicted therein, and hereby agrees to indemnify and hold the City harmless for any intellectual property rights-related claims asserted or threatened against the City in connection with this submission.
- Submission must be accompanied by the completely filled and signed entry form. Incomplete entry forms will be deemed invalid, and artwork will not be judged.
- Artwork will not be returned and all submissions (including the rights to any intellectual property or publicity contained therein) become the property of the City of Bunnell
- A total of one (1) Contest winner will be chosen at the conclusion of the Contest Period. The winner will be chosen by the Centennial Committee and will be recognized at a City Commission meeting with a plaque. The award does not have cash value, and can not be exchanged.
- All submissions must be received at the City of Bunnell front desk, 1769 E. Moody Blvd. Bldg. 2, Bunnell, FL 32110, no later than 12:00 PM on Friday, April 27th, 2012.
- Submitting an entry to this contest and/or acceptance of any award shall constitute and signify the entrant’s agreement and consent that the City of Bunnell may use the entrant’s name, city, state, likeness, age, logo design, picture and/or award information for advertising and promotional purposes worldwide, including the Internet, without limitation and without further payment or consideration, except where prohibited by law.
- All submissions that comply with the Official Contest Rules and have met the guidelines and specifications will be judged by the Centennial Committee. The official logo winner will be announced and the logo unveiled at the Potato Festival on May 19<sup>th</sup>, 2012.
