I have been reading all the "news" about this building being able to be fixed and Hansen/Sullivan's quest not to be proven wrong for sitting on their hands for two and a half years doing NOTHING but wasting tax \$\$ on Revels/Hanns/McLaughlins benefit to "Business associates". I believe had you not been limited that this building would not fail the FBC 2813.1.4.1 and would have been required to prove that a vapor barrier consistent with the requirements of FSB 1907.1 would have been met.

Terracon has proven that FBC 2813.1.4.1 has not been met on this building and Terracons moisture MVER readings of huge disparity must be investigated to show total compliance with FSB 1907.1. This is a new building that must comply and never rely on any claim of "grandfathering". These two items MUST be fully addressed to your satisfaction.

You sir are now the authority of record and John Ruffalo and I will offer you any assistance necessary if anyone forces you to compromise your position as Flagler County Building Official. With our new county manager we have turned the corner from the dark days of failed policy and "special benefits". We appreciate your service to our County.
