The following self-appraisal is based up available data. It is important to note that for the 2022-23 school and district grading cycle, the information returned by the Florida Department of Education is considered baseline. The process used to determine letter grade ratings (based on this baseline data) is not the same as the process used in prior years and going forward. Care should be taken not to equate the outcomes with prior year aggregates without full context of what the scores represent.

Per my contract, 9.2, **Annual Evaluation**; by April 1 of each year, I shall provide the Board a self-appraisal of accomplishments and attainments. The Strategic Plan goals form the basis of this self-appraisal.

Per my contract, 2.6, Agreement Extension; this agreement may be extended upon mutual written agreement of the School Board and the Superintendent.

As I have previously stated at a recent workshop, if this board recognizes the scope of work that I have led merits a contract extension, I welcome consideration of a 6-month to one-year option should the board need more time before deciding on a multi-year contract.

Please note that many figures in this document are Year to Date (YTD), as the data is pulled from the Progress Monitoring 2 session, which is completed at the mid-way point of the school year. Historically the growth in the second half of the school year is substantially greater than that of the first half of the year. Additionally, this is a new state-wide tool being used this year.
