Sometime between 1/26/20 at 6pm and 1/27/20 at 10am, the vehicle was entered by an unknown suspect, who took the battery, battery cables, and air filter box from the engine compartment. Vehicle Fire	20-8845	I-95 @ 296 MM SB	A standalone enclosed trailer was fully engulfed with flames on the shoulder of I-95 SB. The vehicle that was pulling the trailer was able to detach the trailer from the vehicle and get to safety. I-95 SB was shut down and traffic was diverted to US.1 until the Fire Department was able to get the fire under control. FHP responded and took over the investigation (FHPG20OFF002994).

Missing Person (Adult)	20- 8902	Filbert Lane	The caller has not heard from her brother, M1, who is homeless in Hernando County since 01/10/20 and has become very concerned about him due to his narcotic use history. Hernando County refused to take the caller's report over the phone, so a missing person report was completed and M1 was entered into FCIC/NCIC as missing. TTY sent to Hernando County for an attempt to locate, however that met with negative results. Report by Deputy Rosado.
Assist Public	20- 8904	Woodborn Ln	M1 left home after an argument with her father. Units originally responded to a missing juvenile after the female ran away, but she was located down the street and returned home.
Disturbance (Domestic)	20- 8923	Brian Lane	During a domestic violence investigation it was discovered that O1 was the respondent of an injunction for protection related to domestic violence. The petitioner was on scene at the residence as well as O2. Per the active injunction, O2 was not to be within 500 feet of the above residence.
