Domestic Disturbance	19-2572	N Ocean Shore Boulevard	S1 was arrested in reference to domestic battery after she struck her father, V1. Video surveillance of the incident was obtained from the gas station.
Narcotics	19-2605	Palm Coast Parkway NE	A grey Honda Civic was located parked at the community center park after hours. A subsequent voluntary search of the vehicle and occupants resulted in the arrest of S1 for possession of cocaine and paraphernalia.
