



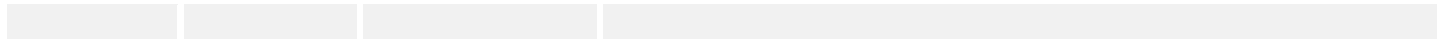
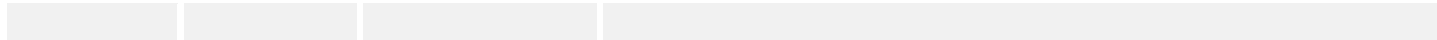

Both parties gave the same account of the incident. S1 was determined to be the primary aggressor and was placed under arrest for Battery-DV. When her husband observed S1 being escorted to the patrol vehicle, he became irate and began yelling and cursing at deputies on scene. He then walked toward the front of the residence, still screaming at deputies. The male then walked inside of the residence and slammed and locked the door.
