The vehicle was a rental from Bolotino and had GPS which showed the vehicle was at 84 Forest Grove. Sgt. Tietje arrived on scene and saw the white Nissan Altima in the road, then observed a B/M exit the driver's door and 2 W/F's exit from the vehicle. All walked toward 84 Forest Grove and the male was trying to take something from his pockets, which turned out to be \$881.00 cash that he dropped in the grass. The male later identified as S1 was secured and had some cannabis in his front left pocket. Inside the vehicle, Deputies located over 123 grams of marijuana, MDMA tablets, Hydrocodone, and drug paraphernalia. Clark was arrested reference Grand Theft MV, possession of marijuana over 20 grams, possession of marijuana w/ intent to distribute, possession of MDMD, possession of hydrocodone, and possession of drug paraphernalia and transported to the FCIF without incident.
