Narcotics	20-19469		Dep. Conway conducted a traffic stop, a search of the vehicle he found 3 Hydromorphone pills and 5 Oxycodone pills. There was an 11 year old male that was in vehicle with them. After speaking to the juvenile, he handed over a baggie containing 11.5 grams of cannabis . The juvenile stated when they were getting pulled over, S1, handed it to him and told him to stuff it in his pants. S1 was charged with Possession of Cannabis under 20 grams and Child Neglect without great bodily harm S2 was charged with Possession of Oxycodone , Poss of Hydromorphone, DWLS with Knowledge and Child Neglect without great bodily harm. DCF was notified and the mother came to pick up her son.
Narcotics	20-19402	CR 305 (Country Store)	A probable cause search during a traffic stop by PACE revealed several baggies of cannabis throughout the vehicle and a non-holstered loaded 9mm handgun under the seat as well as an extended magazine within the vehicle. The juvenile driver, S1, admitted to having the firearm concealed in her possession and handing it to the passenger , S2, who then concealed it under the his seat when the traffic stop was conducted. S1 was arrested for carrying a concealed firearm, possession of a firearm by a minor, and possession of cannabis under 20 grams. S2 was arrested for carrying a concealed firearm and possession of cannabis under 20 grams.
