Domestic Disturbance -Physical	20-28205	Pine Lakes Pkwy	S1 and her husband, who are in the process of a divorce, were involved in a disturbance over marital issues. S1 struck her husband in the right side of his head and he retreated to the bedroom. S1 then kicked the door open and threw an unknown item into the room, which struck her husband in the left eye. S1's husband then pushed her away from him and retreated outside and locked himself in his vehicle and called LE. The victim had a small laceration over his left eye and redness to his right eye, consistent with being struck. S1 was placed under arrest reference Battery-DV and transported to FCIF. Reckless Driver	20-28266	I-95 South	We received a reckless driver complaint passed on by SJSO, that fled from them. Dep. Oldham spotted the vehicle on 95 and attempted to stop it by the Weight Station. The vehicle put a blinker on and started pulling over to the shoulder. The vehicle then took off at a high rate of speed and Dep. Oldham was told not to pursue. As Dep Oldham advised he was exiting at the 284, the vehicle did as well, and went east. Sgt. Tietje was at Old kings and 100 as vehicle passed with a flat tire. Sgt. Tietje activated his lights and the vehicle fled again. Both deputies followed from a safe distance, with no lights or siren. The vehicle was observed turning north on Colbert. As deputies turned on to Colbert the vehicle was on the shoulder, missing a tire, and a white male running from the vehicle. The male was taken into custody just inside the woodline. S1 was arrested for flee and elude and DWLS. Report Dep. Oldham
Assault & Battery	20-28101	Justice Lane (FCIF)	O1 stated that during an argument O2 struck him in the face several times with his fist. The surveillance video showed both subjects throwing punches at the same time. O1 signed a charging affidavit for battery on a detained person that will be forwarded to the SAO. Assault & Battery	20-28197	Justice Lane (FCIF)	Inmates were involved in a physical disturbance in their cell. O1 stated he was just defending himself and did not wish to pursue charges. O2 stated O1 hit him first and he wanted to sign charges. Video surveillance was not able to show who the primary aggressor was. O2 signed charges for battery on a detained person that will be submitted to the SOA. See report by Deputy Dalrymple.
