Burglary Vehicle (Follow up)	20-27018	Veranda Way	PACE conducted a follow up, reviewed axon video which confirmed the suspect was one in the same, disseminated information to CPD, and FCSO was able to quickly locate the male riding a bicycle at the RaceTrac gas station sector 216. S1 arrested for burglary of a conveyance, petit theft, theft of a credit card, 7 counts of fraudulent use of a credit card, carrying a concealed weapon, possession of methamphetamine, and criminal mischief. James also has a warrant out of Mississippi for VOP ref burglary but they will not extradite at this time due to
Domestic Disturbance	20-28565	Profile Place	V1 called 911 and reported that husband hit her in the face. Deputies arrived on scene and made contact with S1, who stated he grabbed the phone from V1 but did not hit her. Contact was made with V1 who had bruising and swelling below her left eye consistent with being punched. S1 was placed under arrest for DV battery.
Baker Act	20-28543	Matanzas Woods Parkway and US1	Adult female placed under a Baker Act.
Violation of Injunction (no contact order)	20-28518	Beachway	S1 stated that O1 truck her with his vehicle while she was walking to her friend's house. Contact was made with O1 who stated that S1 jumped on the hood of his vehicle as he tried to have a civil conversation with her. O1 showed Deputies text messages from S1 stating that she was coming to the residence to grab belongings and threatened to damage his vehicle and residence. S1 was arrested for violation of a no contact order (original charge domestic violence).
Domestic Disturbance	20-28596	Louvet Lane	V1 reported that while she was sleeping, S1 entered her bedroom and punched her multiple times in the face. Deputies arrived on scene and made contact with V1, who had injuries consistent with being punched. Rescue responded to scene and transported V1 to Advent Health. A BOLO was issued for a gray Acura and it was located traveling south on Belle Terre Parkway. A traffic stop was conducted and S1 was placed under arrest without incident.
