Larceny (Grand)	19-30775	Kathleen Trail	RP called to report jewelry missing from her home between 03/22/19 and 03/31/19. Further follow-up required.
Domestic Battery	19-30810	Smollett Pl	V1 advised that her husband pushed her which caused her to fall to the ground. While V1 was falling she struck her head on the corner of the wall causing a deep laceration on her head. V1 bled heavily from the wound and was transported to FHF by rescue. S1 was arrested and transported to FCIF without incident. See report by Deputy Colson for further.
Narcotics	19-30804	Rae Dr	D/S Varnes attempted a traffic stop on a vehicle reference a tag light violation. As he activated his emergency lights, he was dispatched to another call and immediately deactivated his lights. The vehicle fled on Rae Dr, and lost control and crashed into an AT&T box, disabling the vehicle. The driver, S1, fled on foot and jumped into the water canal to evade LEO. Contact was made with S1 at his residence where he advised he was scared and fled because he had a suspended driver's license. A PC search of the vehicle led to finding 249 grams of marijuana, a Smith & Wesson 9MM firearm with the serial number scraped off, 4 Oxycodone pills, and paraphernalia.
