Vehicle Burglary- Delayed	20-21653	Cherry Tree Ct	Victim advised approximately 5 days ago when he left for work, he noticed the trunk of his BMW was open. He then noticed his handgun was missing from the door compartment of his unlocked vehicle. There was cash in the center console of the vehicle that was not taken. Firearm entered into NCIC as stolen. Units arrived on scene quickly and canvassed the area. No persons were located in the area. Surveillance footage showed 2 unknown race, younger males walk up the driveway of 13 Prs. Rose. The dome light of the vehicle comes on and the males walk toward Pritchard Dr. Nothing was taken and the vehicle did not appear to be rummaged through. Assault- Battery	20-21655	Garden St. N. Home Depot	Employee advised an unknown white male in a purple minivan was driving reckless through the parking lot and approached him. The male appeared intoxicated and struck the employee in the chest, 3 times, with a closed fist. The male then got back into his vehicle and left toward Palm Coast Pkwy.
