Overdose(Baker Act)	19-34084	White Feather Ln	61 YOA female alert and conscious transported to Advent Health by FCFR after overdosing on prescription medication. BA paperwork completed by LE and dropped off to ER staff at Advent Health.
Overdose/Poisoning	19-34064	Flaxton Lane	RP advising her adult male son is in the bathroom and overdosed. Upon LEO arrival contact was made with male who was alert and conscious. He was disoriented and sweating profusely. Male was given Narcan injection by paramedics due to his physical condition declining rapidly. Male was transported to FHF for evaluation.
Disturbance	19-34079	Kingswood Lane	Circle K clerk calling and advising there is an intoxicated male outside harassing the customers and has a backpack full of knives he is attempting to sell. Contact with s1 outside store. S1 was intoxicated and belligerent towards LEO. He became aggressive with LEO and was taken into custody for disorderly intoxic.
Domestic Disturbance-Verbal	19-33993	Acorn Ave	O1 grabbed his cell phone from O2, accidentally making contact with her wrist. No violence or threat of violence reported. O1 agreed to leave the residence for the night to eliminate the possibility of any further issues.
Reckless Driver-Narcotics	19-34112	SR 100 @ CR 305	FCSO observed a vehicle traveling WB on W SR 100 estimated to be traveling over 100 MPH. Lights and sirens were never activated, and the vehicle crashed into a ditch as it attempted to navigate a left turn onto CR 305 from W SR 100. S1 exited the driver's side of the vehicle and S2 exited the passenger seat. S1 was taken into custody. As Deputies were attempting to take S2 into custody he kept reaching into his pockets. A search of the vehicle, yielded a backpack, claimed by S1, which contained 2 plastic baggies with crack cocaine. S2 was found to be in possession of a .25 cal semi-auto handgun with 2 rounds in the magazine. S1 was arrested reference possession of cocaine and reckless driving. S2 was arrested reference possession of a concealed firearm, and possession of a firearm by a minor.
