Crash W/Injuries	20-35358	Underwood Trail	A citizen called 911 advising a white vehicle just crashed into the culvert in front of her house and the driver is unresponsive. Female driver eventually came too and contact was made with her. The female refused med on scene. Juvenile in vehicle was not injured. Female driver appeared to be intoxicated and smelled of an alcoholic beverage. Field sobriety exercises performed. Female driver taken into custody reference DUI and child neglect. Juvenile turned over to grandmother. Vehicle towed by rotation wrecker. Report made Deputy Hill and Deputy Douglas
Drunk Driver	20-35445	I-95 Northbound # 288	A concerned citizen reported a reckless driver on I-95. Deputy Parker located the vehicle and attempted a traffic stop after the vehicle failed to maintain lane. The vehicle failed to stop and continued northbound into St. Johns County. A BOLO was sent to St. Johns and FHF reference fleeing and eluding charges. Dep. Parker followed the vehicle in an attempt to obtain a tag and turned off lights and sirens after pursuit was not authorized. The suspect vehicle pulled into a rest area and contact was made with S1. He was subsequently arrested for DUI and fleeing and eluding. St. Johns S.O. towed the vehicle. S1 waived extradition back to Flagler County for processing which was recoded on Axon. 767 charging affidavit completed by Dep. Parker.
Missing Juvenile (recovered)	20-35277	Ricardo Place	M1 returned home to residence. Dep. Beane responded and made contact M1 who was in good health. M1 stated he stayed the evening at a friend's house in Bunnell but would not provide any further details. He was removed from NCIC/FCIC
Domestic Disturbance	20-35347	I-95 Southbound # 287	V1 reported a disturbance with her boyfriend after they exited I-95 to get gas. Deputies observed the vehicle as it was traveling onto the I-95 southbound on ramp from Palm Coast Parkway. Deputies conducted a traffic stop after observing a physical disturbance inside the vehicle. S1 was placed under arrest for DV battery. V1 refused to complete a witness statement or allow pictures. DV paperwork issued. Report made by Dep. Narciso
Overdose	20-35402	Farraday Ln	RP advising he found his 17-year-old daughter in her bedroom and she is unresponsive. RP advised several empty pill bottles lying around. Med unit arrived on scene and transported juvenile to Advent Health. Deputies on scene found a letter the juvenile wrote

and left behind on her bed. The letter explained that she did not wish to live anymore and that she was sorry. The letter was dated with today's date. RP advised that his daughter suffers from anxiety and has attempted suicide before. Baker Act paperwork completed and delivered to the ER. Female was responsive at Advent Health. Report made Deputy Narciso and FTO Ocampo
