<b>TS (Reckless Driver)</b>	19-39530	US1 and Palm Coast Parkway	FCSO attempted to perform a traffic stop on a red motorcycle that was driving reckless. The motorcycle fled Southbound on US1 and was not pursued. A citizen called in that they witnessed the motorcycle wreck on US1 near Enterprise Drive into the woods. S1 was located running behind a business on US1 with several injuries. Vitaliy was transported by EMS to Halifax Hospital. Charges pending on Vitaliy for fleeing and eluding, reckless driving and no valid driver's license.
<b>Crash – Stolen Vehicle Recovered</b>	19-39582	Woodbury Dr	An anonymous complainant called in that he heard a possible crash on Woodbury , he then saw 2 subjects running from the vehicle. When units arrived they found a Mustang Convertible stuck in the swale. Deputies checked the area, but nobody was located. Later it was discovered the vehicle was stolen.
<b>Shoplifting – Narcotics</b>	19-39510	Cypress Point Pwy Walmart	S1 entered Walmart and took a baseball hat from the shelf and put it on his head and attempted to leave without paying for it. When S1 was taken into custody and searched he had 12 small baggies with a brown powder in them, which tested presumptive positive for heroin, 3 full and 3 half pills (Xanax) and 2 syringes. S1 was charged with possession of heroin with intent to sell, possession of alprazolam, possession of drug paraphernalia and petit theft 2nd degree (prior conviction).
<b>Disturbance Domestic</b>	19-39599	Sergeant Ct	O1 wanted to report that his live in girlfriend, O2 vandalized his vehicle. Upon further investigation, it was determined that there was a physical disturbance. O1 no longer wanted to cooperate and O2 had left to go stay with her mom in Ormond.
<b>Stolen Vehicle-recovered</b>	19-39592	Candleberry St	O1 was contacted after a vehicle registered to him, a 2002 Ford bearing Florida ABWC28 crashed at the intersection of Woodbury Dr and Whiteview Pkwy. Vehicle towed to Saxons.
<b>Violation of Injunction</b>	19-39535	Boice Ln	VCSO responded to the above address to assist FCSCO with a 911, upon their arrival it discovered, S1 had an active injunction and was not supposed to be at the residence. FCSCO responded and subsequently arrested S1. S1 complained of abdominal pain while on scene due to a pregnancy and was transported to FHF for treatment.
