Burglary Residential	20-41345	Cherrytree Court	RP reported a delayed residential burglary that occurred sometime yesterday evening (4/30). RP stated at approximately 9:00 p.m. he placed his wallet and money clip on a workbench in the garage. He then woke up this morning and realized only the screen was closed and not the garage door. RP noticed his wallet and money clip missing from the workbench. Report made by Deputy Held.
Follow-up	20-40346	Palm Coast Parkway (Circle K)	Deputy Lentino conducted a follow-up reference a previous fraud case. Deputy Lentino sent TIPS an attempt to identify and was able to identify S1 as a suspect. Contact was made with S1, who post Miranda confessed to being the female who handed the clerk two fraudulent \$20 bills to pay for items. Once the clerk advised her the currency was counterfeit and they were contacting LEO, she left the area. Deputy Lentino submitted a 707-charging affidavit, charging S1 with using counterfeit currency with intent to defraud.
Baker Act	20-41344	US1 (NCL)	St. Johns County S.O. notified our dispatch reference a missing adult traveling south into Flagler County. Deputies located vehicle and conducted a traffic stop on US1. Contact was made with O1 who was confirmed missing out of South Carolina. O1 was placed under a Baker Act after a mental health evaluation.
Disturbance Domestic	20-41334	Sandlewood Lane	Husband and wife were involved in a verbal altercation that escalated to physical when V1 reportedly made a sarcastic comment that enraged S1. V1 sustained a small laceration on his forehead. S1 was arrested as the primary aggressor of the altercation on the charge of simple battery. Report made.
Notification -Welfare Check	20-41305	E Moody Blvd - Call from out of state relative	RP called from Connecticut to advise his son, O1, sent text messages to family/friends containing suicidal remarks. O1 was believed to be visiting a friend in Palm Coast earlier. We located the friend and questioned him about O1's whereabouts. He advised that O1 had not seemed suicidal to him. O1 was confirmed to be at the friend's house earlier, but left heading to the family condo in Pompano Beach, FL. A welfare check BOLO was issued to the I-95 corridor. Report made.
Assist Other Agency	20-41295	Potatoville RD / Underwood AVE (Flagler Estates)	St. Johns County notified dispatch that they had their Fire/Rescue en-route to a medical call reference an unconscious male in the Flagler County side of Flagler Estates. A 39 year old male was working on his property all day in the sun. His family said he was

complaining about not feeling well and asked for them to get him a water. When they returned with the water, they found him on the ground and unresponsive. They called 911 and rescue transported him to Flagler Hospital in St. Augustine for treatment. The male reportedly has a health history. The FCSO was notified that the male was later pronounced dead at the hospital at 1918 hours. No foul play suspected. Report made.
