Missing Person Adult (Found)	19-44776	San Pablo Ct	FCSO conducted a follow up and located M1 at the location. M1 was removed from NCIC/FCIC as missing by Flagler County Communications. Kurtis had a warrant out of Pinellas county, which advised they would extradite. See additional Case number, 19-45591.
Disturbance	19-45599	Old Kings Rd S	Units responded to the above location due to a male, later identified as Darren Kuback, yelling in the trailer park looking for his son, S1. S2 attempted to run into the trailer stating that his son was inside with a warrant. Contact was made with S1 who was secured and the warrant was confirmed out of Volusia. After S1 was secured, S2 attempted run into the trailer again and S1 ran out of the trailer for a short distance while handcuffed. S1 was arrested for his out of county warrant, escape and battery on LEO. S2 was arrested for obstruction and battery on LEO.
Reckless Driver-TS	19-45527	Town Center @ Royal Palms	Anonymous caller advised a black Chevy Silverado was traveling at a high rate of speed, and cutting other drivers off in traffic. Upon contact with the driver S1 became belligerent and refused to exit the vehicle, stating she did not believe the deputies were real LEO. S1 rolled the window of her vehicle up and called 911. Dispatch advised her to comply with deputies at which time she exited the vehicle. S1 then became more irate, and threatened to kick Deputy Rossi, with the apparent ability and intent to do so. S1 was placed under arrest reference resisting w/o and assault on LEO.
Missing Person-Adult	19-45523	Bruning Ln	O1 reported that S1 left this residence at approximately 2130 hours on Monday, 5-13-19 to go to Walmart, and has not returned. Local and surrounding counties BOLO sent and tag entered into the hotlist. S1 was entered into NCIC as a missing person.
Assist Public (Missing-Recovered Juv.)	19-45553	Burnley Pl	RP advised her 9YOA son ran out of the home while her 16 YOA daughter was watching him. The juvenile was located by school administrators and brought to the main office of BTES.
Animal Bite	19-45552	Ridley Ln	Vivian Estes reported that her 10 YOA son was playing in the front yard, when a neighbor's dog escaped from the front door of their residence. The 1 YOA Labrador mix ran up to the juvenile and bit him on the hip. The juvenile was able to escape and run to his residence.
