18-48648	Criminal Mischief	Laughing Gull Lane	V1 and V2 stated their neighbor, S1, came onto their property and broke several landscaping lights. S1 was upset because V2 sold him a house that has several problems. S1 agreed to pay for the damages but the V2 wanted to sign charges. A 707 was completed and will be turned into the SAO.		
18-48728	Disturbance- Domestic	Brookhaven Ct S.	O1 and O2 were in a argument over a cell phone. There was a struggle between the two over the phone. O2 then gained control of it and throw it, because his wife is always on her phone. Neither party wanted to pursue the incident further. O2 went to his parents for the night, so there was no chance for further fighting.		
18-48700	Disturbance- Domestic	E. Seward Trail	O1 and O2 were involved in an argument . O2 stated that O1, who is in a wheelchair, ripped one of the interior doors and frame off and threw it. He then threw a glass cup at her and one at the dog. O1 stated that O2 ripped the door off and threw cups. Both parties refused to go to a shelter, both agreed to sleep in separate rooms.		
18-48308	Disturbance- Domestic	Bren Mar Lane	O1, stated that her mother, O2, were involved in a verbal altercation when O2 threw a pair of sunglasses which struck her in the chest. O1 has a history of filing false reports and O2 was unable to be located. An attempt was made to contact O2, which was met with negative results. A card was left with a request for O2 to contact the Sheriff's Office so a follow up can be conducted. Charges are pending further investigation.

Upon making contact with the driver, O1, he advised that he had a loaded firearm locked in his center console. O1 consensually handed Deputies the firearm, which was enclosed in a holster. A FCIC/NCIC check of the firearms serial number showed that it was reported stolen out of Miami Dade County on 3/12/18. O1 stated he had purchased a vehicle at an auction and the firearm was inside. O1 was able to show Deputy Beausoleil where he purchased the vehicle and did his own stolen status check of the firearm online. The firearm was placed into evidence and contact was made with the entering agency.
