18-42569	Disturbance – Domestic	Renworth Lane	V1 and her live in boyfriend S1 got into an argument, which turned physical. V1 attempted to call for help, but S1 took her phone and smashed it. V1 then went to a neighbors to call 911 with her juvenile son. S1 left the residence prior to LEO arrival. A Charging affidavit was completed for: Agg assault DV , Battery DV and tampering with a witness.
18-42500	Death	Patchogue Lane	Male deceased. No foul play suspected.
18-42575	Violation of Injunction	Palm Lane	S1 violated a Temporary Injunction for Protection Against Domestic Violence, by contacting the petitioner via email. Charges were completed and forwarded to the SAO.
18-42515	Violation of Pretrial Release	Banton Lane	S1 called V1 from the Flagler County Inmate Facility which is Violation of the Pre-trial release stating that she can have no contact with the victim who is V1. S1 was arrested at the FCIF.
18-42539	Disturbance- Domestic	Beckner Lane	Units responded due to a third party caller heard S1 arguing with V1, while they were on the phone with her. It was discovered that there was a no contact order in place from a previous incident. S1 was to have no contact with V1, yet he was living back in the house with her. S1 was taken into custody for Violating the condition of release, stating that would be no contact.
18-42360	Residential Burglary	Riverfront Drive	Sometime over the past 10 days an unknown person(s) entered the construction site at Riverfront Dr. The unknown person(s) force entry into several condos, damaged several windows and spray painted several items. The damage was estimated to be between \$3500-5000.
18-42522	Overdose	Laurel Avenue	W1 stated that O1 was not breathing due to overdosing on heroin. Medical personnel responded to the scene and administered Narcan, which was successful. O1 regained consciousness and was transported to Florida Hospital Flagler.
18-00042604	Battery	Justice Lane	V1, was spit on by S1. The incident was recorded on video surveillance and witnessed by a corrections deputy. Simple Battery charges submitted to SAO.
18-42520	Physical Disturbance	Old Dixie Hwy	S1 stated that S2 came to his residence and started banging on the door. S1 stated when he exited the residence and S2 grabbed him and pushed him to the ground. S2 stated he did go to S1's residence to discuss an issue about a fence post. S2 stated when

S1 exited the house S1 he punched him in the face and pushed him to the ground. Charges for battery on a person over 65 were signed on both subjects at their request and submitted to the SAO for further review.
