Structure Fire	19-56164	Cypresswood Drive South	Propane tank started fire on the rear porch. All occupants were able to evacuate without injury and nothing suspicious was observed.
Crash W/ Injuries (THI)	19-56167	State Road 100 (Chrysler)	Units responded reference a vehicle that drove off the roadway and crashed into a pole in front of the dealership causing very minor damage. Male transported to Advent Health where he was pronounced deceased. Investigation turned over to FHP.
Narcotics	19-56162	Palm Coast Parkway NE	S1 was the front passenger in a white Toyota (FL tag KSRK67) that was stopped. During a probable cause search of the vehicle straws containing a white substance and a brown substance were located on the front passenger floorboard and tested presumptive positive for cocaine and methamphetamine. S1 was arrested and charged with possession of methamphetamine, possession of cocaine and possession of drug paraphernalia.
Fraud (Follow Up)	19-55207	Raemoor Drive	Sergeant Weaver performed a traffic stop on S1 for a bicycle violation. S1 admitted to having a counterfeit bill in his possession and admitted post-Miranda to passing two fake \$10 bills on 6-13-19 at Dollar General. S1 was placed under arrest and charged with possession of methamphetamine, possession of drug paraphernalia, possession of a counterfeit pay instrument and possession of personal identification information of another.
Crash W/Injuries	19-56210	Hargrove Grade & Short Canal Grade	While riding in the bed of a pick-up truck, O1 fell off the back of the truck onto the dirt road. Upon initial contact male became combative and was secured. Male transported to Advent Health via ambulance.
Juvenile Incident	19-56279	Pineland Lane	S1 was observed running a stop sign in the area. FCSO attempted a traffic stop on the vehicle but it turned its hazard lights on and drove to Pineland Lane failing to stop for law enforcement. At the residence the driver exited the vehicle and resisted deputies attempts to secure him and refused to identify himself. S1 from previous encounters and it was discovered that he was also on probation and in violation of his curfew. S1 was arrested and charged with fleeing, resisting without violence and VOP (2019-56272).
Disturbance Domestic	19-56161	Lancewood Street	S1 was arrested for domestic battery after pushing her boyfriend of three years, causing a laceration to his arm.
