Disturbance Domestic	19-56438	Ferdinand Lane	Stephanie Tirado called 911 and dispatch overheard a struggle where a male stated that he was going to break the female's arm. FCSO arrived on scene as V1 and S1 were getting into a vehicle to leave and V1 ran towards deputies while S1 was secured in handcuffs. S1 advised she was choked and struck several times by S1 when he found out she had called 911 S1 forced her out of the residence and into the vehicle to try to help him flee the scene. S1 was arrested for kidnapping, felony domestic battery with a prior conviction, domestic battery by strangulation and criminal mischief.
Shooting	19-56479	Cherokee Court E	Units responded to the residence in reference to shots fired. Reporting party advised that S1 shot a gun during an altercation. FCSO located the suspect vehicle and a felony stop was conducted. S1 was secured and it was discovered he had what appeared to be a gunshot wound to his left thigh. S1 was transported to Halifax Hospital via ambulance where he was treated and released. S1 was placed under arrest after he was released from the hospital and charged with aggravated battery on a pregnant woman. S1 was transported to Volusia County Branch Jail, initial report by Deputy Malta.
Disturbance Domestic	19-56473	County Road 305	V1 called 911 advising that she had been abducted. V1 was eventually located on County Road 305 near a crashed white van. V1 advised she left Georgia on Friday with her ex-boyfriend, S1, and that he struck her multiple times in the face while in the van driving. V1 advised that she attempted to exit the van several times and that S1 would grab her and keep her from exiting the van. A perimeter was established and AirOne responded, observing a subject possibly curled up in the woodline. K9 deployed into the woods and S1 was apprehended with a K9 bite to his shoulder. S1 was arrested for domestic battery and false imprisonment and transported to Advent Health for medical treatment.
Death	19-56450	Rosewood Street	FCSO responded to an unresponsive male, John Corbett, at the residence and deployed AED and performed CPR on the male who was later pronounced deceased at Advent Health.
Narcotics	19-56440	Lancewood Street	FCSO performed a traffic stop on a silver Subaru for speeding. After a positive K9 alert by Deputy Smith's partner, S195 was arrested for possession of amphetamines and tampering with evidence.
