Overdose	20-58562	Holly Road	A 29 year old male was found by his father unresponsive and appeared to have been overdosing on suspected fentanyl. Deputy Faircloth and Deputy Cuthbert each administered a dose of Narcan that revived the male. The male was transported to Advent Health by rescue.
Traffic Stop	20-58550	SR 100 @ Landing Blvd	Deputy attempted to stop a black Chevrolet Malibu. The vehicle did not stop and began to travel at a high rate of speed westbound on SR 100 and ran the red light at Belle Terre Pkwy. A pursuit was not authorized. The vehicle slowed down near Wendy's and stopped. A traffic stop was completed and contact was made with the driver, S1. S1 was secured and was arrested for reckless driving, resist officer w/o violence, aggravated fleeing and eluding and threat to LEO.
Civil	20-58491	Kiwanis Way	Trailer missing from Kiwanis Storage unit. LPR shows trailer was moved on Friday 6/19/20. Due to circumstances, this is believed to be a civil matter. No entry made at this time.
Overdose	20-58480	Sherwood Street	A 37 year old male was found by his father cold to the touch but breathing. Paramedics on scene administered 4 doses of Narcan and transported the male the Advent Health where he was stabilized and expected to make a full recovery.
Baker Act	20-58533	Main Street	Adult female was placed in custody under a baker act for inflicting self-harm to herself and was transported to Advent Health by rescue for medical attention. The baker act paperwork was turned over to Advent staff.
Traffic Stop	20-58569	USHY 1 S @ CORD 304	Deputy attempted traffic stop on a vehicle. The vehicle accelerated and fled traffic stop. Vehicle was not pursued. The vehicle was found abandoned a short time later at E. Magnolia. A perimeter was established and K9 deployed. AirOne was requested. Two subjects were found hiding in an enclosed pool enclosure at a nearby residence. Both were charged with burglary, resisting without violence, and felony drug charges.
